

**CONSENT  
to the processing of personal data**

I give my consent to the processing of personal data to the Commission for Public Selection Commission (hereinafter – the Commission).

Personal data will be processed in order to ensure consideration and processing of documents and information about me in connection with the competitive selection for the position of Independent Member of the Supervisory Board of the State Enterprise “Medical Procurement of Ukraine” (hereinafter - SE “MPU”), as well as for purpose of forming a list of potential candidates selected from among the applicants, to be determined by the Commission within one year from the list of applicants for replacement in case of the candidate's refusal, non-appointment or early termination of powers of the Independent Member of the Supervisory Board of the SE “MPU”.

1. The following personal data will be processed by the Owner: education information, profession, specialty and qualification, scientific degree, academic title, professional development, passport data, data about awards, information on financial obligations, property status, autobiographical data, labor activity and work experience information, professional competences, personal information (name, patronymic(if available), surname, age, gender, marital status, family composition, etc.), information about registered or actual place of residence, registration as an individual person in the State Register of individuals - taxpayers, electronic identification data (biographical certificates, telephone numbers), image records (photos).

2. The Owner will carry out the following actions with personal data:

- analysis and processing of personal data, using personal data, which involves the owner`s any actions of personal data to process such data, their protection, as well as actions to grant partial or full right to process personal data to other subjects of relations related to personal data, carried out with the consent of personal data subject or in accordance with the Law of Ukraine "On Personal Data Protection" (Article 10 of the said Law), except for the actions specified in paragraph 4 of this consent;

- personal data distribution, which involves the information transfer about individual person with the personal data subject`s consent (Article 14 of the said Law);

- personal data access to third parties carried out in accordance with this agreement or legal requirements.

3. The Owner shall perform the following actions with personal data:

- the analysis and processing of personal data, the use of personal data, which includes any actions by the personal data owner for processing, and protecting such data, as well as actions to grant partial or full rights to process personal data to other entities in relationships related to personal data, conducted with the consent of the data subject or in accordance with the Law of Ukraine "On Personal Data Protection" (Article 10 of the specified Law), excluding the actions specified in paragraph 4 of this agreement;

- the dissemination of personal data, which includes actions to transfer information about an individual with the consent of the data subject (Article 14 of the specified Law);

- access to personal data by third parties, conducted in accordance with this agreement or legislative requirements.

4. Personal data will be transferred to:

- the recruitment company involved in the selection process, for the purpose of verifying candidates for the position of an independent member of the Supervisory Board of SE "MPU"; conducting preliminary selection of participants and maintaining communication with them; assessing all selection participants for compliance with the requirements for candidates for the position of an independent member of the Supervisory Board of SE "MPU," as approved by the Commission; creating a list of potential candidates selected from the applicants, from which replacements may be drawn within one year in the event of candidate withdrawal, non-appointment, or early termination of an independent member of the Supervisory Board of SE "MPU";

- the National Police of Ukraine to obtain information on the absence (or presence) of criminal records, restrictions on holding specific positions, or engaging in certain types of activities for candidates;

- the Commission to determine the candidacy of the applicant for the position of an independent member of the Supervisory Board of SE "MPU";

- the governing entity of SE "MPU" to form a list of potential candidates selected from the applicants, from which replacements may be drawn within one year in the event of candidate withdrawal, non-appointment, or early termination of an independent member of the company's Supervisory Board.

I agree to provide updated, accurate information and original documents for the update of my personal data during the selection process for the position of an independent member of the Supervisory Board of SE "MPU" in the event of any changes to my data.

I have been informed about the processing of personal data as any action or set of actions, such as collection, registration, accumulation, storage, adaptation, modification, updating, use, and dissemination (distribution, sale, transfer), anonymization, and destruction of personal data, including the use of information (automated) systems.

Consent is granted for the period necessary to achieve the purpose specified in clause 1 of this agreement and can be withdrawn by submitting a written statement to the personal data owner. Personal data will be destroyed one year and two months after the completion of the selection process for the position of an independent member of the Supervisory Board of SE "MPU."
